FAQ

1. Is ChildWatch coming back?

YES! ChildWatch is being rebranded as Kids Zone and will open Nov 1.

2. What are the hours?

At first Kids Zone will be open limited hours: Mon – Thur, 9 - 11 and 4:30 - 6:30. Hours will be added based on demand. Families may use Kids Zone for up to 2 hours/day.

3. Who can take advantage of Kids Zone?

Kids Zone is complimentary for Family Memberships. Coming soon, Adult, Young Adult and Seniors will also be able to take advantage of Kids Zone for children or grandchildren with a Youth Guest Pass.

4. Will you take infants and toddlers?

Not currently. To comply with COVID regulations, we will not be able to accept children under age 3.

5. What do I need to register?

Pre-registration is not required, however; Kids Zone Registration Paperwork and COVID Waivers are required prior to using Kids Zone. Please know that may change if we have an overwhelming response.

- 6. How do I check in for Kids Zone?
 - a. Let the Welcome Center staff know you will be using Kids Zone at check in. They will hand you bracelets to fill out for you and your child(ren). Markers to fill them out will be in Kids Zone.
 - b. After you have filled out your bracelets and put them on your child(ren), please sign in on the computer available in the Kids Zone check in area.
- 7. Is there any other paperwork required for my child(ren) to use Kids Zone?

Yes, please complete the registration form available at the Welcome Center. This document will be kept on file and only needs to be completed once.

Health

Your child's health and safety is of major importance to the YMCA staff. Please advise the staff at the time of check-in about any special health problems (i.e. asthma, allergies, etc.) we need to be aware of as care-takers of your child/ren. In consideration of the other children and staff, we ask that you not bring your child to the Y Kids Zone with the following symptoms:

- Fever of 100 degrees or higher. Children must be fever free for 24 hours before joining us at the YMCA.
- Vomiting one or more times in the last 24 hours
- Diarrhea
- Fever and chills, nausea or vomiting sore throat, cough, loss of taste or smell, headache, congestion or runny nose
- Draining rash

- Eye discharge or "pink eye"
- Green nasal discharge
- Lice or gnats
- No medication of any kind will be administered by Kids Zone staff
- Missed School due to illness. If your child has had a contagious disease, please contact the YMCA office regarding the contagious illness so a general notice (all names will be kept confidential) can be posted for other parents. The following conditions are categorized as "highly contagious":
- Strep throat
- Chicken pox
- Scarlet fever

- · impe
- Measles or mumps
- Viral infections
- Impetigo
- Lice
- Covid-19

- Influenza
- Gastroenteritis
- Hand, foot, and mouth disease

We reserve the right to deny children admittance to Kids Zone if they show signs of illness.

Activities

- Children can choose from a wide variety of activities from playing a board game, making music, creating art masterpieces, reading a story or playing in the land of make believe.
 Dress up costumes, blocks, puzzles, books and more are available. We have something for everyone.
- Because different ages need different challenges, we've designed our Kids Zone Rooms to let children progress at their own level. Our goal is to make sure your children have fun, while they play and gain self-confidence.
- Children that are not potty trained will start in the Child Watch room. Once the staff feels
 they are ready to progress into the Amazing Kids room, they are free to move to the other
 area. This is usually age 3 and potty trained but depends on the child's developmental level.

Check-in Procedures

- Upon your first visit to the Kids Zone rooms, you will be given a parents' handbook.
- Parent/guardians will be allowed a brief introduction to the room to help adjust the child to the new environment upon their first visit.
- Each visit to the room the parent/guardian will sign their child/ren in on the sign in and sign out sheet.
- Parent/guardian and child/ren will receive a bracelet. Parents will be responsible for writing their child/ren's names and ages on the bracelets. Bracelets must remain on while child/ren are in Child Watch.
- Maximum time allowed for any child in the Kids Zone is 2 hours per day.
- Parent must remain in the building while their child is checked into our Kids Zone rooms.
- No child will be accepted into the Kids Zone program less than 15 minutes before close.

Check-Out Procedures

- The parent/guardian who signs in the child must be the same person who leaves with that child, unless otherwise noted on the sign-in sheet along with a parent's signature.
- Whoever picks up the child may be required to show a driver's license, state I.D. or have verification through the YMCA Check in system before YMCA staff can release the child. This rule will be strictly enforced and is for the children's safety and protection.
- The parent/guardian will show proper identification, initial the sign in/out sheet, and a staff member will retrieve the child for the parent.

General Rules

- If your child requires a diaper or clothing change, the staff will notify you. We do not change diapers or clothing.
- We do not allow snacks or food in our rooms due to food allergies and choking hazards.
- Your child can bring a water bottle with liquid in it, but their name must be clearly labeled on the bottle.
- We do allow formula for babies but ask that it is prepared in advance, and that all baby items be labeled clearly.

Discipline

Children will be encouraged to behave in a caring, honest, respectful, and responsible manner while playing at the center and to cooperate with others and the staff.

All discipline actions will be handled by the following steps:

- Questioning from the staff to the child, followed by an explanation of proper behavior.
- Verbal warning by staff.
- An age appropriate time out will be applied (removal from activity).
- Behavior notice will be given verbally by a staff member to the parent/quardian.
- If the child has a continual behavior problem the parent/guardian will be asked to meet with the Director for a conference.
- Children with major discipline problems may be asked to leave the program.

Staff

 Children who join us in the Amazing Kids & Child Watch rooms are cared for by well trained, experienced YMCA staff. These men and women are selected on the basis of their maturity, leadership capabilities, patience and understanding and all are certified in First Aid and CPR.
 Staff and operations are under the direct supervision of a YMCA professional director.

Emergency Procedures

- · An injury will be recorded on an incident report form.
- For emergencies, such as small cuts, bruises, or bumps, the following procedures will be followed:
- » A staff member will take appropriate steps for the injury
- » Parent/guardian will be notified.
- » The injury will be recorded on an incident report form.
- In case of severe medical emergency, the following procedures will be followed:
 - »Staff will call 911
 - »Parent/quardian will be notified
 - »Staff member will take appropriate steps for injury.
 - »The injury will be recorded on an incident report form.
- In the case of fire drill or building evacuation, children will be escorted by staff to the
 meeting place by the dumpsters in the back of the parking lot. If parents wish to take their
 children from this area, they will be asked to provide photo identification.

We are also following additional guidelines from the CDC for the safety of your children:

- Limited capacity is required to meet social distancing requirements.
- All surfaces sanitized are frequently by our staff.
- All cloth toys, costumes and soft-surface items are removed.
- Plastic toys such as blocks, trucks and playsets are sanitized two times per day at scheduled breaks, after each use.
- Bathrooms are sanitized after each use.
