Association Highlights

Raised \$2.38 million through the Annual Campaign, special events, and contributions to enhance the Y's mission and impact.

Served more than 250 youth in the BellXcel summer learning program, where participants gained an average of 0.5 months in literacy and 1.5 months in math skills.

Celebrated the retirement of President and CEO Harold Sparrow and Chief Financial Officer Bob Herr.

Welcomed Jim O'Rourke as the sixth President and CEO of the YMCA of Greater Hartford.

Appointed new senior leadership staff: Brandi Fitzgerald, Vice President of Finance and Chief Financial Officer; Angie Matthis, Vice President of Marketing and Communications; and Mike Tedesco, Chief Commercial Officer.

Entered into a management agreement with the Regional YMCA of Western Connecticut to provide finance and human resources support.

Received a \$135,000 gift from the Roxanne and Henry Brandt Foundation to teach 1,000 kids how to swim.

Engaged Gro Development to create facility master plans for Farmington Valley, Indian Valley, and Hale YMCAs.

Secured a two-year, \$250,000 Cigna Foundation grant to launch the Health Passport Program at Wilson-Gray, in partnership with Trinity Health Of New England.

Downtown Hartford YMCA

Expanded youth swim access through support from the Roxanne and Henry Brandt Foundation, providing 750 youth with free swim lesson sessions.

Strengthened the leadership team with the hiring of Senior Program Director Joshua Sedgwick, Health & Wellness Director Samantha Linner, and Membership Director Mike Antonio.

Delivered water safety education to 13 local schools, reaching more than 4,800 students and teaching essential safety skills.

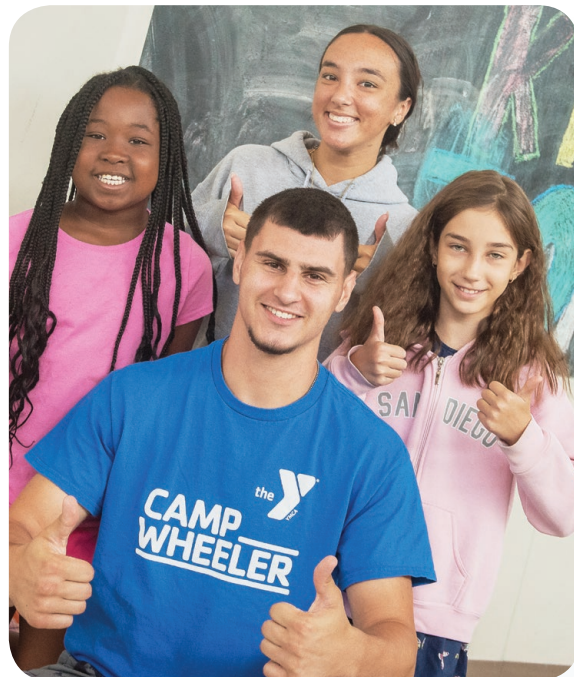
Provided free swim and adaptive swim lessons to 840 children, building confidence and life-long skills.

Certified 85 individuals in life-guarding, CPR, and babysitting.

Surpassed 265,000 visits, including more than 55,000 group exercise participants who completed 6,532 workouts and logged 1,270,704 Myzone Effort Points (MEPS).

Supported 34 participants through LIVESTRONG® at the Y and raised \$36,000 at the annual Bike for the Battle event.

Celebrated competitive achievement as the Tsunamis Swim Team earned Bronze Medal Club status, secured two national titles, five top-10 finishes, and 32 new team records.



Installed a new playground, made possible through an anonymous donation, enhancing summer camp and the overall member and family experience.

Glastonbury/Tri-Town YMCAs

Opened a new after-school site at Gideon Welles School, serving fifth- and sixth-grade students.

Launched the first Wethersfield BellXcel summer learning program, where 22 students maintained their reading and math skills.

Strengthened early learning leadership with the hiring of Ashlie DeMarco as Child Development Director for Tri-Town/Glastonbury Preschool and the promotion of Cassidy Flanagan to Child Development Director of Glastonbury School Age.

Introduced an indoor soccer program for children ages 2-5.

Hale YMCA Youth and Family Center

Launched the first phase of a Wellness Center enhancement, expanding strength training space and adding new equipment.

Opened a second school-age childcare site at Eastford Elementary School, now serving 31 children and supporting working families.

Hosted seven blood drives in partnership with the American Red Cross and Putnam Rotary, collecting 253 pints of life-saving blood for local hospitals.

Celebrated longtime staff member and YMCA champion Christine Earhardt's 70th birthday with a community swim party, where she generously gifted \$25,000 to support the purchase of Aqua Cycles, with ABS Aqua Cycling launching in early 2026.

Supported 38 children in learning to swim, bike, and run through Race4Chase Camp, culminating in participation in the Race4Chase Triathlon in Newport, RI.

Indian Valley Family YMCA

Hosted Music for a Mission fundraising event, raising \$51,722 to support YMCA programs and services.

Exceeded the Annual Support Campaign raising a total of \$90,291.

Hosted three blood drives in partnership with the American Red Cross and two vaccination clinics in partnership with CVS Pharmacy.

Served 171 children through summer camp programs, with 25 campers receiving \$37,233 in financial assistance to ensure access.

Served 24,251 meals through Child Development programs, supporting the health and well-being of the children in our care.

West Hartford YMCA

Received \$15,550 from the West Hartford Old Guard's annual golf tournament to provide summer camp scholarships for students in the BellXcel summer learning program.

Celebrated 40 children graduating from the BellXcel summer learning program.

Established a partnership with the University of Saint Joseph to provide swim lessons for children ages 6 months to 12 years, serving 28 swimmers in the program's first year.

Continued a longstanding partnership with Westminster Presbyterian Church, engaging 100 children in a youth basketball skills program for ages 3-8.

Wheeler Regional Family YMCA

Received a \$2,000 grant from the Main Street Community Foundation to enhance outdoor archery space and underground area of summer camp.

Collected 800 pounds of food to support the Plainville Community Food Pantry.

Continued partnership with American Red Cross as a host site for five blood drives, collecting 113 units of blood with the potential to impact up to 339 lives.

Received a \$5,300 grant from the McPhee Foundation to purchase a new lifeguard chair, bolstering pool safety.

Secured a \$10,000 grant from the Petit Family Foundation to help support adaptive aquatic programming, serving 24 children through the Adaptive Aqua Buddies program.

Wilson-Gray YMCA Youth and Family Center

Opened a new pre-K classroom, expanding early learning opportunities for families in Hartford.

Remodeled the Wellness Center to enhance the members health and fitness experience and renovated the Teen Center to create a welcoming space that reflects the look and feel of a healthy home environment.

Launched the LIVESTRONG® at the Y program, supporting cancer survivors in their recovery journeys.

Recognized by the American Red Cross as a National Sickle Cell Initiative Partner for consistent leadership as a blood drive host site.

Advanced community engagement goals through events including Shop with a Cop, supporting 15 families during the holidays; a Back-to-School event distributing more than 300 backpacks with free hair services; the James Anthony Green Basketball Tournament, raising \$10,000 to support LIVESTRONG®; and a Thanksgiving dinner serving more than 300 meals.



Raised more than \$74,000—exceeding 136% of the Annual Campaign goal—to provide free teen memberships and financial assistance for camp, membership, and YMCA programs.

Received a \$5,300 grant from the McPhee Foundation to purchase a new lifeguard chair, bolstering pool safety.

Secured a \$10,000 grant from the Petit Family Foundation to help support adaptive aquatic programming, serving 24 children through the Adaptive Aqua Buddies program.

Celebrated 70 years at the Colebrook location, honoring Camp Jewell's legacy and traditions.

Served more than 8,000 individuals through impactful, year-round programs.

Baked more than 17,000 cookies, raising over \$28,000 in scholarships to expand access to camp.

Expanded adventure programming with new ropes courses at Camp Jewell and Camp Chase.

Prepared and served more than 130,000 meals in the dining hall.

Welcomed more than 100 alumni back to camp for the annual Corn Roast celebration.

YMCA Camp Woodstock

Welcomed 1,136 campers for a summer filled with connection, growth, and the magic of camp.

Achieved the Annual Campaign goal, raising \$120,000 to provide 120 children access to camp who otherwise could not afford it.

Strengthened water safety and skill development as 294 campers participated in swim lessons, with 87 advancing to the next level.

Engaged over 2,000 individuals and hosted more than 50 community organizations during the non-summer seasons, reinforcing Camp Woodstock's role as a year-round resource.

Advanced international service efforts as the Camp Woodstock International Committee raised funds to send four summer staff members and two board members to volunteer with the YMCA in the Dominican Republic. In partnership with The ARC Cookie Factory, Springfield College, and YMCA alumni, the team helped build two homes for families in need, extending Camp Woodstock's spirit of service beyond the local community.

Partnered with Ellis Technical High School to renovate the waterfront patio, creating a welcoming multi-purpose space for connection, recreation, and community gathering.

Installed a new PA sound system to strengthen safety and emergency preparedness.

Conducted four camper focus groups engaging more than 70 participants, gathering insights that are shaping future renovations and program development.

“Because someone asked—that is how my volunteer journey with the Y began.”

For Tim, what started as a simple request grew into decades of leadership, service, and connection to the YMCA of Greater Hartford.

Tim’s relationship with the Y began when his family enrolled their daughter Erin in a preschool program at the Indian Valley Family YMCA. Through those early connections, a conversation with former YMCA leader Risa Filkoff led to an invitation to serve on the branch advisory board. Although he hadn’t grown up with the Y, Tim believed that when someone asks for help, the right thing to do is say yes.

That decision sparked a long and meaningful journey of volunteer leadership. Over the years, Tim has served in numerous roles, including chair of the Indian Valley and Camp Woodstock advisory boards and member of the YMCA of Greater Hartford Board of Directors. Today, he continues to provide leadership as Treasurer and Chair of YMCA of Greater Hartford’s Finance Committee, helping guide the fiscal stewardship that supports the Y’s mission across the region.

While Tim is quick to say his contributions have been “an accumulation of little things rather than one big thing,” his impact has been significant. Working alongside other dedicated volunteers, he helped guide the success of Camp Woodstock’s capital campaign—an

effort that strengthened one of the YMCA’s most cherished institutions and ensured that future generations of young people will continue to find friendship, confidence, and a sense of belonging at camp.

The YMCA has also become deeply woven into Tim’s family life. His wife, Kate, spent many years working in the Indian Valley preschool program, and all four of their children—Erin, Brigid, Molly, and Colleen—spent time at Camp Woodstock and later held their first jobs with the YMCA. Those experiences helped shape a strong family commitment to service, leadership, and community.

For Tim, the most meaningful part of his involvement has been the people. The friendships formed through years of volunteer leadership—and the opportunity to support passionate staff and volunteers—have made his journey with the Y especially rewarding.

Receiving the Robert C. Knox Jr. YMCA Distinguished Leadership Award is both humbling and meaningful for Tim, particularly when he reflects on the leaders who have received it before him.

Looking back, he hopes his legacy is simple: that his example encourages others to give a little more of themselves.

“If I’ve inspired even one person to do a bit more than they otherwise might have,” he says, “then that would mean something.”
